Small Business¹ Fee Reduction Incentive (Citywide)

Notes:

¹ - "Small Business" for the purposes of this incentive program means a business, once developed, employing 25 persons or less. Project applicant must present written documentation related to this employee threshold. This is a reimbursement program, not an initial waiver of fees. Fees must be paid up front.

² - Downtown Core means the Urban Residential or City Center zones of the City. Qualifying projects are ones in which a land use proposal is submitted that would eliminate a non-conforming use or develop a vacant property in those areas.

Administrative Fees are defined as building permit, plan check, site plan review, technical review committee, storm inspection, plumbing and mechanical permit, water meter installation, sewer hookup inspection, encroachment permit, land disturbance permit, and environmental checklist fees.

No other fee shall qualify for this discount, and the Community Development Director reserves the right to deny a refund request. Written requests must be made by applicants for either a reimbursement of funds or a waiver of funds depending on program.

This section of the Municipal Fee Code expires December 31, 2014.

Violations: Deviating from an approved set of plans without prior review and approval is subject to an investigation fee in addition to the re-review fee and/or valuation assessed fee.

Commencing work *prior to issuance* of a permit will be assessed a fee in addition to the permit fee. The additional fee is equal to the amount of the permit fee required by the code.
