**DEFENDANT'S OBLIGATIONS:**

The defendant hereby waives his/her right to a speedy trial and a trial by jury under Court Rules and the State and Federal Constitution as they presently exist or as hereinafter amended. This waiver is effective until: \_\_\_\_\_.

The defendant hereby agrees and stipulates to the admissibility and accuracy of the police reports filed in this cause as competent and sufficient evidence of guilt for the crime charged above. The defendant agrees to the continuance of this action by the Court during the duration of the deferral. Defendant agrees to the conditions indicated below in Additional Obligations.

**ADDITIONAL OBLIGATIONS:**

In domestic violence cases, unless otherwise agreed between the parties, the defendant is subject to conditions of No Contact with the Victim and may not possess firearms during the period of the deferral.

- ☐ Defendant shall not commit any criminal offenses (any charge where probable cause is established by a court) during the period of this Agreement.
- ☐ Defendant shall enter into and successfully complete counseling.
- ☐ Defendant shall report as required to the City of Ferndale Probation.
- ☐ Defendant shall not consume alcohol or non-prescribed controlled drugs for the duration of this agreement. Defendant is subject to random urinalysis or breath testing.
- ☐ Defendant shall not consume cannabis in any form.
