ACTIVITIES COMPLETED IN 2014

In fiscal year 2014, the Transportation Benefit District (TBD) generated \$392,177. Two projects were undertaken using TBD funds in 2014, as outlined below.

Barrett Road (Smith Road to Main Street) This project provided for the resurfacing of just over one mile of Barrett Road by pulverizing the existing roadway pavement and placing a new hot mix asphalt driving surface. Two existing pedestrian ramps at St. Helen's Lane were also replaced to ensure ADA compliance. Construction was completed in late September 2014. In addition to the TBD funding, the City obtained \$380,000 in state grant funds from the Transportation Improvement Board's Arterial Preservation Program. A summary of project expenditures is shown below:

Church Road (Main Street to Heather Drive) The majority of the work on this total roadway reconstruction project was completed in 2014, including installation of new water, sewer, and stormwater utilities, relocation of existing overhead power and communications lines, installation of new LED street lighting, roadway widening and paving, construction of retaining walls and sidewalks, and landscaping. The project was suspended for the winter, with the remaining work, including top lift of asphalt and street tree planting to occur in early 2015. In addition to the funding from the TBD, the City obtained a \$800,000 grant from the Washington State Transportation Improvement Board's Urban Arterial Program, as well as a \$1,980,000 federal grant from the Surface Transportation Program. We were able to successfully transfer surplus grant funds from last year's Thornton Road Project and leftover right of way grant funds to utilize a total of \$2,060,575 in federal grant funds for the project. The City's utility funds covered costs associated with the various utility improvements. A summary of project expenditures is shown below:

The available TBD cash balance at the end of the 2014 fiscal year was \$139,290.

ACTIVITIES ANTICIPATED FOR 2015

An additional \$360,000 in anticipated revenue is forecasted to be received in 2015. At the close of 2014, the attached TBD project list identified the following projects for construction in 2015:

Main Street I-5 to Third This project includes crack sealing the roadway, as well as pavement repair via removal and replacement of a damaged roadway section in the vicinity of LaBounty Drive. The construction cost is estimated to be \$100,000, which is anticipated to be financed in its entirety by utilizing TBD funds.

Main Street I-5 to Barrett Road This project includes crack sealing the roadway, as well as pavement repair via removal and replacement of a damaged roadway section in the vicinity of the north leg intersection of Barrett Road. The construction cost is estimated to be \$400,000, which is anticipated to be financed in part by TBD funds and supplemented by REET 2 funds.

Third Avenue Alder Street to Main Street This project includes reconstruction of the roadway and sidewalks, as well as installation of pervious pavement and sand filtration systems to intercept and treat stormwater runoff. The total project construction cost is estimated at \$385,000. The project will be funded in part by TBD funds if available. While this project is listed for construction in 2015, the start date is contingent upon whether or not the City receives grant funds from the Department of Ecology's water quality program. The DOE will issue its final offer list in July.
