<u>ITEM 1</u>

Bid Proposal Form, ITEM NO. 11, "Removing and Reinstalling Wire Fence and Post", has been revised to read "Removing Wire Fence and Post".

Bid Proposal Form, ITEM NO. 39, "Silt Fence", the quantity has been decreased.

Bid Proposal Form, ITEM NO. 45, "Raised Pavement Markers Type 1", the quantity rounding has been corrected.

Bid Proposal Form, ITEM NO. 46, "Raised Pavement Markers Type 2", the quantity rounding has been corrected.

Page 85, lines 23 to 26, are revised to read:

Removing Wire Fence and Post

This work shall consist of removing and disposing of an existing wire fence including posts, anchors, and braces. Wire fencing and posts shall be removed in their entirety. No close cutting of posts will be permitted.

<u>ITEM 8</u>

2-02.4 Measurement

Page 86, lines 19 to 20, are revised to read:

Removing wire fence and post will be measured by the linear foot along the line and slope of the fence prior to removal and as staked by the Engineer.

<u>ITEM 9</u>

2-02.5 Payment

Page 86, lines 39 to 42, are revised to read:

"Removing Wire Fence and Post", per linear foot.

The unit Contract price per linear foot for "Removing Wire Fence and Post" shall be full payment for all costs for the specified Work including disposal, and all other requirements, unless covered in a separate Bid Item in this section.

ITEM 10

A Bidder has contacted the Contracting Agency regarding additional exploratory excavations.
