Maul Foster & Alongi, Inc. (MFA) has prepared this memorandum on behalf of the City of Ferndale (the City) to summarize the completion of Deliverable #2. The work completed for Deliverable #2 includes developing the scope of the Greenhouse Gas (GHG) Emission Inventory and proposed methods for data collection, data analysis, and reporting per the GHG Emissions Reduction Subelement section of the Washington State Department of Commerce's Climate Element Intermediate Planning Guidance (Section 4, Pathway 3, Tasks 1.1 – 1.8)<sup>1</sup>.

The tasks completed include the following:

- Task 1.1: Identify Emissions Inventory's Scope and Plan
  - The City's emission inventory will include a combination of Scope 1, Scope 2, and 0 Scope 3 emission sources, detailed in the table below.
